Third Arrest Made In May 25th Homicide Investigation

Thibodaux Chief of Police Bryan Zeringue announced the arrest of Danzell Andrae Washington (B/M, 27), of Thibodaux, LA for Second Degree Murder (Felony).

On Wednesday, June 26, 2019, the Thibodaux Police Department Narcotics Detectives assisted the Assumption Parish Sheriff's Department in arresting Danzell Washington on an active City Court of Thibodaux Warrant for Second Degree Murder (Felony). Danzell Washington was apprehended in Assumption Parish, after leading police in a vehicle pursuit. Danzell Washington was also found to be in possession of a large amount of narcotics, which he was additionally charged with by the Assumption Parish Sheriff's Office. Danzell Washington remains incarcerated at the Assumption Parish Jail on a \$1,000,000.00 bond. Danzell Washington also has 7 other outstanding Contempt of Court Warrants through the City Court of Thibodaux with a combined \$7,691.50 bond.

On Friday, June 14, 2019, the Thibodaux Police Department made an arrest on the second suspect in the May 25th murder of Travontae Williams. Investigators questioned Travis Kentrell Williams on Friday, June 14th. Information obtained during the interview led investigators to obtaining a warrant for Travis Williams for Principal to 2nd Degree Murder. Travis Williams was booked and is still being held at the Lafourche Parish Correctional Complex with a \$500,000.00 bond.

Travis Williams and Danzell Washington's warrants stemmed from a homicide that took place on Saturday, May 25th, 2019, shortly after 2:00 a.m. The investigation led Detectives to link John Washington, Travis Williams and now Danzell Washington as suspects in the case. John Washington was previously arrested and held at the Assumption Parish Jail, until later being transferred to the Lafourche Parish Correctional Complex. Mr. Washington also still remains held on a \$1,000,000.00 bond.

The homicide on Saturday, May 25th, 2019, claimed the life of Travontae Williams (B/M, 22) of Thibodaux, LA.

Officers responded to the 1400 block of Plantation Road, in reference to a report of gun shots being fired. Upon arrival, Travonte Williams was found deceased on scene from at least two suspected

gunshot wounds. Travonte Williams' body was found near the intersection of Midland Drive & Planation Road, with no suspects on scene.

The incident still remains under investigation and Detectives are not ruling out other suspects. A suspected motive of the shooting is being withheld at this time, in attempt to protect the integrity of the investigation. More information will be released as it can be made available to the public.
