

PETITION FOR ANNEXATION
INTO THE CITY OF THIBODAUX, LOUISIANA

1.

TO THE HONORABLE COUNCILMEN AND COUNCILWOMEN OF THE CITY OF THIBODAUX, STATE OF LOUISIANA. I, Troy J. Bellanger, the Vice President and duly authorized representative of J.B. Levert Land Company, L.L.C., do hereby declare that the said organization does own property in the Parish of Lafourche, State of Louisiana, known as Parcels 1, 2, 3 & 4, with said organization wishing to have said property included in the corporate limits of the City of Thibodaux, State of Louisiana. That the above described property is vacant land with no resident property owners nor registered voters residing on it.

J.B. Levert Land Company, LLC's consent to the petitioning of the above described land for annexation into the City of Thibodaux, is predicated upon the City of Thibodaux adhering to several stipulations regarding the use, zoning, servicing of utilities and acquisition of public right of ways for the said tracts of land. J.B. Levert Land Company, LLC reserves the right to withdraw this Petition for Annexation and it's consent to incorporate the land herein if for whatever reason, through no fault of the J.B. Levert Land Company, LLC, one or more of these stipulations cannot be met or adhered. The stipulations are as follows:

- a. Approximately 195 acres of land located on the northwestern most side of Rienzi more particularly described and marked as "Proposed C-2 ± 195 Acres" on "Exhibit A" shall be zoned as C-2.
- b. Approximately 4 acres of land bounding the west side of Louisiana Highway 20 on Abby Plantation and more particularly described and marked as "C-1" on "Exhibit A" shall be zoned as C-1.
- c. Approximately 105 acres of land located on the northwestern most side of Rienzi more particularly described and marked as "Proposed R-1 ± 105 Acres" on "Exhibit A" shall be zoned as R-1.
- d. Approximately 170 acres of land bounding the west side of Louisiana Highway 20 on Abby Plantation and more particularly described and marked as "Proposed R-1 ± 170 Acres" shall be zoned as R-1.
- e. J. B. Levert Land Company, LLC or its successors in title shall be granted full sewer capacity for the land being annexed and have the right to bring sewer to and utilize the City's nearby waste water treatment facility to service the properties.
- f. J. B. Levert Land Company, LLC or its successors in title shall not be required to utilize City' water or natural gas in the development of the approximately 174 acres of land bounding the west side of Louisiana Highway 20 on Abby Plantation, and shall be allowed to utilize existing utilities bounding the Property. Notwithstanding the foregoing, should

the City at its sole cost and expense extend water and/or natural gas service to this property, J. B. Levert Land Company, LLC agrees to utilize its services.

- g. The City agrees to assist in the acquisition of and/or provide J. B. Levert Land Company, LLC with any right-of-ways for utilities that may be required to develop the approximately 174 acres of land bounding the west side of Louisiana Highway 20 on Abby Plantation.
- h. The annexed property is to be exempt from the City of Thibodaux property taxes as long as it remains in Agricultural use.
- i. J.B. Levert Land Company, LLC reserves the right to withdraw this petition if these stipulations are not approved and adhered to.
