## AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE AN INTERGOVERNMETNAL AGREEMENT WITH ST. GENEVIEVE CATHOLIC ELEMENTARY SCHOOL TO PROVIDE A SCHOOL RESOURCE OFFICER

**BE IT ORDAINED** by the City Council of the City of Thibodaux in regular session assembled, that:

**WHEREAS**, the Thibodaux Police Department and St. Genevieve Catholic Elementary School desire to work together to provide a POST certified Police Officer to perform the duties of a School Resource Officer (SRO); and

**WHEREAS**, the duties and responsibilities of the SRO are outlined in an Intergovernmental Agreement between the Thibodaux Police Department and St. Genevieve Catholic Elementary School; and

**WHEREAS**, the SRO will be paid salary and benefits by the Thibodaux Police Department, and St. Genevieve Catholic Elementary School will reimburse the Thibodaux Police Department 100% of the salary and benefit costs; and

**WHEREAS**, in order for the City to enter into an Intergovernmental Agreement with the Clerk of Court, it is necessary for the City Council to adopt an ordinance authorizing the Mayor to do so.

**NOW, THEREFORE BE IT ORDAINED** by the City Council of the City of Thibodaux that the Mayor is hereby authorized to execute an Intergovernmental Agreement with the Lafourche Parish Clerk of Court Office for the use of the off-street parking facility as outlined in the agreement.

**BE IT FURTHER ORDAINED** that a copy of the said agreement is attached hereto as Exhibit "A" and thereby made a part hereof.
