At its meeting on March 4, 2020, the Planning and Zoning Commission reviewed a request by Leslie Clement on behalf of Percy & Donna Smith, Ad-Val, Inc., Lloyd Gibson and Herbert Richard c/o Otto Richard to re-zone property located between 1317 thru 1303 St. Charles Street from an R-3 Zone to a C-1 Zone. The Planning and Zoning Commission has recommended approval of the request. Councilman Naquin read the Following:

One of the items on the agenda for today is to introduce an ordinance to rezone a vacant lot and other property on both sides of that vacant lot near the intersection of St. Charles St and Canal Blvd. from R-3 to C-1 so that the lot can be sold by its present owner to individuals who want to use the property as a specialty restaurant which would basically be a snow ball stand that would also sell hot dogs and light snacks. The lot is located next to an existing lounge which was "grandfathered" as an exception to the current R-3 zoning. On the other side of the vacant lot is an apartment with another building which is used as a recording studio. Next door to that property is another apartment building. The owners of all four of the properties are asking that all of the properties be rezoned to C-1. The four pieces of property at issue are the last four pieces of property at the end of St. Charles St. Property across the street is already zoned for commercial use.

No one appeared at the hearing of the Planning and Zoning Board to object to the rezoning, and I am not aware of any objection to the rezoning by the owner of any neighboring property.

The Council adopted Ordinance No. 3042 to completely amend and re-enact Article IX of the Thibodaux Zoning Ordinance – Signs. The Council also adopted four amendments to this ordinance as recommended by the advisory committee and Planning and Zoning. John Lafargue has requested that Planning and Zoning consider an amendment to Section 908 (B) (3) & (4) pertaining to the location of off premise signs (billboards).

Mr. Lafargue's proposed changes to these sections would be to stipulate that digital signs cannot be placed within 1500 feet from the major intersections along Hwy 1 and 308, as outlined in the ordinance. He is also proposing that the City remove the stipulation that new sign permits will be granted in order to relocate existing signs. This would not allow any new signs to be permitted within the City limits.

The Zoning Administrator informed the Council Administrator that the Commission considered this request at their meeting on January 8, 2020 and their recommendation to the City Council is to deny this request.

This item failed with a vote of 0-5.

The Council adopted Ordinance No. 3042 to completely amend and re-enact Article IX of the Thibodaux Zoning Ordinance – Signs. The Council also adopted four amendments to this ordinance as recommended by the advisory committee and Planning and Zoning. John Lafargue has requested that Planning and Zoning consider an amendment to Section 908 (E) pertaining digital off premise signs (billboards).

Mr. Lafargue's proposed change to this section would be to create Sub-Section 2 in order to stipulate that digital signs cannot be exchanged for a legal, but non-conforming sign grandfathered by Ordinance No. 3042. The concern with this request is that upon adoption of Ordinance No. 3042, there are no longer any non-conforming signs in the City. He also added the effective date of the sign ordinance as September 3, 2019, which is not correct. The ordinance was adopted on September 3rd and the effective date was September 21st.

The Zoning Commission considered this request at their meeting on January 8, 2020 and their recommendation to the City Council is to deny this request.

The Council adopted Ordinance No. 3042 to completely amend and re-enact Article IX of the Thibodaux Zoning Ordinance – Signs. The Council also adopted four amendments to this ordinance as recommended by the advisory committee and Planning and Zoning. John Lafargue has requested that Planning and Zoning consider an amendment to Section 908 (F) (1) (d) pertaining to lighting of off-premise signs (billboards).

Mr. Lafargue's proposed change to this section would be to add a statement of City policy to follow the Louisiana Administrative Code Title 70, Part III, Chapter 1, Subchapter C, Section 132 for the erection and maintenance of digital billboards. He also requested to add 5 additional regulations for the message display on digital billboards. The concern with this request is that the Code he is referencing is that the code he is referencing is an administrative policy used by the State Division of Administration. The City generally doesn't include any administrative policy within our code, and to stipulate that our policy is to utilize the DOA policy is not something that the Council Administrator feels should be included in the City code. The 5 items that Mr. Lafargue requested to be added to the regulations of digital billboards came directly from the State Administrative Code that he wants to reference. It is the Administrator's opinion that this would be the proper way to incorporate items in the Administrative Code into our ordinance, without stating that our policy is to follow their policy.

The Zoning Commission considered this request at their meeting on January 8, 2020 and their recommendation to the City is to approve this request.

A discussion took place relative to Section (d) which states that it is the policy of the City of Thibodaux that the erection and maintenance of outdoor electronic advertising signs where indicated comply with the rules and regulations promulgated by latest revision to Louisiana's Administrative Code Title 70, Part III, Chapter 1, Subchapter C, Section 132.

AN ORDINANCE TO AMEND AND RE-ENACT ARTICLE IX SECTION 908 (F)(1)(d) OF THE THIBODAUX ZONING ORDINANCE – LIGHTING OF OFF PREMISE SIGNS

BE IT ORDAINED by the City Council of the City of Thibodaux in regular session assembled, that Article IX Section 908 (F)(1)(d) of the Thibodaux Zoning Ordinance is hereby amended and re-enacted so as to read as follows:

ARTICLE IX. – SIGNS

Sec. 908. - Off-premise outdoor advertising.

- F. Lighting of off-premises signs.
 - 1. Off-premise signs may be illuminated, subject to the following restrictions:
 - d. Message Display:
 - i. Any Digital Display containing animation, streaming video, or text of images with flash, pulsate, move or scroll is prohibited.
 - ii. The content of a digital display must transition by changing instantly, with no transition graphics (e.g., no fade-out or fade-in).
 - iii. Each message must remain stationary for a minimum of eight (8) seconds.
 - iv. Message changes must be accomplished within four (4) seconds.
 - v. Message must be accomplished in such a manner that there is no appearance of movement of the message or copy during the change.
 - vi. Digital displays must include a default design that will freeze the sign in one position if a malfunction occurs.
 - vii. On stacked sign structures, changeable message signs only allowed one per side.
