AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A RIGHT-OF-WAY AGREEMENT WITH ENTERGY LOUISIANA, LLC FOR THE CONSTRUCTION OF ELECTRIC POWER SERVICE FOR THE NORTH THIBODAUX WASTEWATER TREATMENT PLANT

WHEREAS, the City is constructing the new North Thibodaux Wastewater Treatment Plant and desires to grant a ten (10') foot exclusive servitude to Entergy Louisiana, LLC in order to extend electric power service to the facility; and

WHEREAS, it is necessary to grant the exclusive servitude in order for Entergy Louisiana to have access to the property for the location, construction, reconstruction, improvements, repairs, inspection, patrol, replacement and maintenance of electric power and communication facilities for the new wastewater treatment plant; and

WHEREAS, it is necessary to authorize the execution of the right-of-way agreement by the adoption of an appropriate ordinance.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Thibodaux that the City does hereby authorize the Mayor to execute a right-of-way agreement with Entergy Louisiana, LLC for the construction and maintenance of the electric power service for the North Thibodaux Wastewater Treatment Plant.

WHEREAS, in order to establish the crime victim task force, and the responsibilities of both parties, it is necessary to execute a Cooperative Endeavor Agreement with the Houma Police Department outlining the terms and purpose of the cooperative effort between the public agencies; and

WHEREAS, in order for the City to execute this proposed amended agreement it is necessary for the Council to authorize the Mayor to do so.
