The Finance Director has received a proposal for the renewal of the City's Inland Marine Insurance coverage for the period July 18, 2024 through June 1, 2025. The proposal was submitted by USI Insurance Services, LLC with Great American Insurance Company.

Ms. Hebert is recommending that we renew our coverage with USI Insurance Services with an annual premium of \$28,936.00 on a TIV (Total Insured Value) of \$4,829,929.00. There is a .47% decrease in TIV, and the premium is a decrease of 8.7% from last year.

WHEREAS, LA R.S. 29:726(F)(3)(b)(iii)(aa) and 29:726 (F)(4) specify that, in order for the City to participate in the temporary housing program, a certification must be submitted to GOSHEP waiving land use regulations relating to permitting for the temporary placement of mobile homes, recreational vehicles, and other temporary housing directly adjacent to the disaster survivor's damaged dwelling; and

WHEREAS, in order to make expedited funding available to the City for temporary housing and shelter assistance in case of major disaster or emergency, the Thibodaux City Council authorizes the Mayor to execute and submit the "Expedited Temporary Housing Assistance Waiver of Land Use/Permitting Form" opting into the expedited temporary housing assistance program by September 1st of each year.

THEREFORE, BE IT RESOLVED, that the Mayor be authorized to execute and submit to the Governor's Office of Homeland Security and Emergency Preparedness an "Expedited Temporary Housing Assistance Waiver of Land Use/Permitting Form" in accordance with LA R.S. 29:726(F)(3)(b)(iii)(aa) and 29:726 (F)(4) (Act 526,2022).
