The minutes of the August 20, 2024 City Council Meeting were approved as written.

The Fire Department intends to issue bonds in an amount not exceeding \$6,000,000 to finance the construction of the new Central Operations Center. Because the Fire Department provides fire protection within the jurisdiction of the City of Thibodaux, the City must authorize and conduct a public hearing on behalf of the fire department in connection with the bond issuance.

Their Bond Counsel, Brennan Black with Foley and Judell, has provided the Council Administrator with the appropriate resolution that will authorize the publication of the notice of public hearing. That notice will be published once the date and location are established.

A RESOLUTION AUTHORIZING THE CITY OF THIBODAUX TO HOLD A PUBLIC HEARING ON BEHALF OF THE THIBODAUX VOLUNTEER FIRE DEPARTMENT, INC., IN CONNECTION WITH THE ISSUANCE OF BONDS BY THE DEPARTMENT; AND PROVIDING FOR OTHER MATTERS IN CONNECTION WITH THE FOREGOING.

WHEREAS, the Department intends to issue not exceeding \$6,000,000 of bonds, promissory notes, or other evidences of indebtedness (the "Bonds") for the purpose of financing the acquisition, construction, reconstruction, and/or improvement of the Central Operations Center; and,

WHEREAS, the Bonds have been approved by the Louisiana State Bond Commission; and,

WHEREAS, it is necessary for the City to hold a public hearing for the Bonds as required by the Internal Revenue Code; and,

WHEREAS, the City now desires to authorize the holding of a public hearing for the Bonds on behalf of the Department and to provide for other matters in connection therewith;

NOW, THEREFORE, BE IT RESOLVED that the City hereby approves and authorizes the publication of a Notice of Public Hearing and does hereby further approve and authorize the conducting of a public hearing for the Bonds following such publication in accordance with the requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.

BE IT FURTHER RESOLVED that the Mayor and Council Administrator are hereby further authorized and directed, for and on behalf of the City, to execute and deliver all such documents, certificates and other instruments as may be required to effectuate the purposes of this resolution.

The City administers the Section 8 Rental Assistance Program funded through the U.S. Department of Housing and Urban Development.

The City has received the new 2025 fair market rents as published by HUD. The City now has to update our Section 8 Program Administration Plan so as to set the rental payment standard percentage of fair market rents based on the local rental market and funding availability. Effective January 1, 2025, the Section 8 payment standard will be set at 110% of FMR for 1, 2, 3, and 4 bedroom units. In order to establish the new revised payment standards they must be approved and adopted by the City Council in the form of a resolution.

On motion of Councilman Mire, seconded by Councilman Taylor, the Council voted on a resolution to authorize the Section 8 Housing Choice Voucher Program to adopt payment standards at 110% of the Fair Market Rent for 1, 2, 3, and 4 bedroom units effective January 1, 2025 for re-certifications, and October 1, 2024 for all move ins. BE IT RESOLVED by the City Council of the City of Thibodaux in regular session assembled, that:

WHEREAS, the City Council of the City of Thibodaux, Louisiana approved the City's Section 8 Program Administrative Plan; and

WHEREAS, agencies are allowed to establish a payment standard at any level between 90% and 110% of the published fair market rent based on the local rental market; and

WHEREAS, due to the HUD published fair market rents for 2025, the City Office of Housing and Community Development has to update the said plan so as to set the rental payment standard percentage of the published fair market rent (FMR) based on the local rental market and funding availability; and

WHEREAS, it is necessary for the Council to approve this amendment by means of the adoption of an appropriate resolution

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Thibodaux does hereby approve the amended Section 8 Program Administrative Plan so as to establish the new rental payment standard at 110% of FMR for one (1) bedroom units at \$1027.00, 110% of FMR for two (2) bedroom units at \$1260.00, 110% of FMR for three (3) bedroom units at \$1520.00, and 110% of FMR for four (4) bedroom units at \$1670.00 effective January 1, 2025 for all re-certifications, and October 1, 2024 for all new leases.

The Lafourche Parish Assessor's Office has notified the City that it is time to consider the adoption of an ordinance to levy the City's ad valorem tax millages for the year 2024.

The millage assessments were adjusted for 2024 based on the statewide reassessment that was conducted this year. Due to an increase in the City's Taxable Property Valuation, our millage rates were rolled back so that we collect the same revenue as last year. We will have the option to roll forward to our prior year's maximum millage rate before the next reassessment is conducted.

ORDINANCE NO. 3357

AN ORDINANCE TO AMEND AND RE-ENACT CHAPTER 9, ARTICLE II, SECTION 9-3 OF THE THIBODAUX CITY CODE OF ORDINANCES – FIRE BOARD

BE IT ORDAINED by the City Council of the City of Thibodaux in regular session assembled, that Chapter 9, Article II, Section 9-3 of the Thibodaux City Code of Ordinances is hereby amended and re-enacted so as to read as follows:

Chapter 9. Fire Prevention

Article II. Fire Board

Sec. 9-3. - Creation; membership; organization; meeting times; function.

There is hereby created a fire board composed of two (2) representative members from each company of the fire department, along with the Fire Chief, Assistant Fire Chiefs, Treasurer, and Secretary. The selected officers other than the representatives from each fire company shall serve as representatives of the entire department. The treasurer, selected by the fire board, shall be a nonvoting member of the fire board and shall not serve as one of the representatives of his particular fire company. The secretary, selected by the fire department, shall also be a non-voting member of the board and shall not serve as one of the representatives of his particular fire company. The board shall be given supervision of all matters pertaining to or otherwise relating to the good government of the volunteer fire department. The tenure of office of the board members shall be for a term of one (1) year. The board shall meet at least once

monthly for the transaction of business. The date of such meeting shall be decided by the board at its first meeting. The board shall adopt the rules contained in Robert's Rules of Order in all cases except when it has adopted its own rules and regulations and except when such rules and regulations are in conflict with the City Code of Ordinances at which time the City Code of Ordinances will supersede Robert's Rules of Order. The board shall appoint its committees and when necessary will appoint the chairman of the committee.

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A COOPERATIVE ENDEAVOR AGREEMENT WITH THIBODAUX VOLUNTEER FIRE DEPARTMENT, INC.
