The City Council of the City of Thibodaux assembled in regular session at its regular meeting place, City Hall, 310 West 2nd Street, Thibodaux, Louisiana, on Tuesday, October 1, 2024 at 5:00 P.M.

The minutes of the September 17, 2024 City Council Meeting were approved as written.

The City administers the Section 8 Housing Choice Voucher Program funded through the U.S. Department of Housing and Urban Development.

HUD requires that all Section 8 Programs adopt a PHA (Public Housing Agency) 5-year Plan and Annual Plans in accordance with the provisions of the Quality Housing and Work Responsibility Act.

The Housing and Community Development Director has compiled a 5-year PHA plan for fiscal years 2025-2029, and the Annual Plan for FY 2025. It is necessary to submit both plans to HUD so as to comply with the aforesaid Federal Legislation. In order for HUD to recognize the plans as the City's Official plans, they must be approved and adopted by the City Council in the form of a resolution.

On motion of Councilman Mire, seconded by Councilman Richard, the Council voted on a resolution to authorize the Mayor to submit the City's Section 8 Housing Choice Voucher Program 5-Year PHA Plan for FY 2025-2029, FY 2025 Annual Plan, and Certifications to HUD. A RESOLUTION AUTHORIZING THE MAYOR TO SUBMIT THE CITY'S SECTION 8 HOUSING CHOICE VOUCHER PROGRAM 5-YEAR PHA PLAN FOR FY 2025-2025, FY 2025 ANNUAL PLAN, AND CERTIFICATIONS TO HUD

BE IT RESOLVED by the City Council of the City of Thibodaux in regular session assembled, that:

WHEREAS, Section 511 of the Quality Housing and Work Responsibility Act imposes certain requirements on public housing agencies; and

WHEREAS, the requirements include the preparation of a five-year plan and an annual plan to be submitted to the U.S. Department of Housing and Urban Development; and

WHEREAS, the City of Thibodaux, Section 8 Housing Choice Voucher Program, has completed a PHA 5-Year Plan for FY 2025-2029, a FY 2025 Annual Plan, and certifications

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Thibodaux does hereby adopt the Housing Choice Voucher 5-Year PHA Plan for Fiscal Years 2025-2029, and the Fiscal Year 2025 Annual Plan, and authorize the Mayor to sign all certifications and documents for submission to the U.S. Department of Housing and Urban Development.

Councilman Taylor introduced an ordinance to amend and re-enact Chapter 4, Article II of the Thibodaux City Code of Ordinances – Mardi Gras Parades. The Public Hearing on this ordinance will be held at the Council meeting on October 15, 2024.

Due to the Canal Boulevard Bridge Replacement Project, there will be upgrades to the traffic signals at the intersections of LA 1 and LA 308. In order to construct the signals at LA 1 a temporary 40'x40' servitude is required on Circle K's property for the placement of a mast arm, foundation, and pole.

AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE A TEMPORARY SERVITUDE AGREEMENT WITH ANTHONY P. PRESTON FOR THE PLACEMENT OF A NEW TRAFFIC SIGNAL MAST ARM, FOUNDATION, AND POLE AS PART OF THE CANAL BOULEVARD BRIDGE REPLACEMENT PROJECT

BE IT ORDAINED by the City Council of the City of Thibodaux in regular session assembled, that:

WHEREAS, the City is replacing both spans of the Canal Boulevard Bridge which will include the redesign of the traffic signals at LA1 and LA 308; and

WHEREAS, it is necessary to grant a forty by forty (40'x40') foot servitude on the Circle K property for the placement of the mast arm, foundation, and pole for the new traffic signal at LA1; and

WHEREAS, it is necessary for the Mayor to execute a temporary construction servitude with the owner of the property, Anthony P. Preston granting the City the required servitude.

NOW, THEREFORE BE IT ORDAINED by the City Council of the City of Thibodaux that the Mayor is hereby authorized to execute a temporary construction servitude with Anthony P. Preston for a 40'x40' area of Circle K property for the placement of a new traffic signal light pole and mast arm.
