On motion of Councilman Naquin, seconded by Councilwoman Crochet, the Council voted to adopt the minutes of the January 20, 2025 City Council Meeting as written. Upon roll call the vote was as follows:

Bryan Fontenot, 406 West 3<sup>rd</sup> Street, addressed the Council with an update on the last Legislative Session and informed everyone about upcoming legislation that could affect the City.

In accordance with the provisions of Chapter 9, Article II, Section 9-8 of the Thibodaux City Code of Ordinances, it is the duty of the City Council to make the appointments to the Thibodaux Volunteer Fire Department's Fire Board.

The appointments to the Fire Board are based on those selections made by each Fire Company.

On motion of Councilman Naquin, seconded by Councilman Richard, the Council voted on Amendment #1 to correct a typo in the resolution approving the appointment of the 2025 TVFD Fire Board. Upon roll call the vote was as follows:

**LA DOTD received bids for the Downtown Thibodaux Sidewalk Project that is being constructed through Highway Trust Funds through the State DOTD. Since Federal funds are being used for the construction, the project was bid through DOTD, and the City must now concur with the low bid received by the State and authorize the Mayor to execute a construction contract that is also provided by DOTD for this project.**

**The lowest responsible bid was received from Command Construction Industries, LLC in the amount of \$1,046,962.90, and DOTD is requesting that the City concur with acceptance of the low bid and the award of the construction contract, and authorize the Mayor to execute the contract.**

**On motion of Councilman Richard, seconded by Councilwoman Crochet, the Council voted on a resolution accepting the low bid of Command Construction Industries, LLC for the Downtown Thibodaux Sidewalk Project – State Project No. H.013429 and authorizing the Mayor to execute the construction contract therewith. Upon roll call the vote was as follows:**
