PROFESSIONAL SERVICES AGREEMENT AMENDMENT #1

DESCRIPTION OF ADDITIONAL SCOPE

The scope change included in this amendment will adjust the contract fee to reflect the latest budgetary cost as well as adjusting the contract for additional effort required to prepare the amendment budget narrative and ancillary documents for submittal to LWCF. The increased budget is required to provide the design of all project components included in the budget narrative. The fees for structural engineer review and design were backed out as those services were not required for the design. Construction observation services were added to account for site visits and reporting efforts during construction as identified in the approved budget narrative. Material testing has also been included in the additional scope to quality control construction operations. A testing estimate is being provided for the required testing in the amendment. Testing will be performed at a per test rate in accordance with the attached rate sheet from South Louisiana Testing and Inspection, Inc.
