

OFFICIAL MINUTES OF THE PLANNING AND ZONING MEETING CITY OF THIBODAUX THIBODAUX, LOUISIANA July 3, 2024

The Planning and Zoning Commission of the City of Thibodaux assembled in regular session at its regular meeting place, City Hall, 310 West 2^{nd} Street, Thibodaux, Louisiana, on Wednesday, July 3, 2024 at 5:00 P.M.

The minutes of the June 5, 2024 Planning and Zoning Commission Meetings were approved as written.

Breaud introduced request by Larry J Cole Jr to be granted a special exception to place a 16' x 64.5' mobile home on a lot located at 263 Sanders Street within an R-4 Zoning District in accordance with Section 307 of the City of Thibodaux's Comprehensive Zoning Ordinance.

Larry Cole Jr was present to represent his request. He stated that he bought this lot and would like to put a mobile home on it. He added that this process was delayed because he was trying to get funding from the Louisiana Restore program.

Breaud asked if a mobile home was on this lot previously, and Cole said yes, it belonged to a friend. Breaud then asked if all utilities were on site, and Cole confirmed that everything was there. Cole was then asked by Breaud if he had plans to put any skirting around the bottom of the trailer, and Cole said yes, that was part of his plan. Kearns stated that this area of town already had several mobile homes so this request is reasonable.

Upon request for City Administration, Assistant Public Works Director Trey Waguespack stated that the City has no objection to this request.

On motion by Ledet, seconded by Andrews, the Board voted to approve the request by Larry J Cole Jr to be granted a special exception to place a $16' \times 64.5'$ mobile home on a lot located at 263 Sanders Street within an R-4 Zoning District in accordance with Section 307 of the City of Thibodaux's Comprehensive Zoning Ordinance.
